FOOD PANTRIES

SOUTH WOOD EMERGING PANTRY SHELF (SWEPS):

Located at 331 12th Avenue South, Wisconsin Rapids. Provides food for those in need in south Wood County. Individuals will receive a seven day food and hygiene (if available) supply packed by volunteers. Screening held on location during the operation hours of Monday, Wednesday, Thursday, and Friday from 12:00-4:00pm and Tuesday from 4:00-7:00pm. 715-422-2050.

MOBILE FOOD PANTRY:

CHRISTIAN LIFE FELLOWSHIP FOOD PANTRY:

Distributes pre-packaged bags on Tuesdays from 6:30-8:30pm; and Thursdays from 1:00-3:00pm. Valid ID with current address required. Located at 600 7th Street, Port Edwards.

RUBY'S PANTRY:

No qualifications to participate; just a \$20 donation to cover the cost of transportation. Held the third Saturday of every month. Mobile food distribution site located at

COMMUNITY MEAL SITES

THE NEIGHBORHOOD TABLE:

Serves free meals every Thursday and the last two Tuesdays of the month from 4:30-6:00pm at United Methodist Church, 441 Garfield St., Wisconsin Rapids. Carry-outs for homebound and others not able to attend in person available on Thursdays only. Carry-outs must be requested by noon on Thursdays by calling 715-422-1980. No screening process or "qualifications" in order to participate.

AGING & DISABILITY RESOURCE CENTER SENIOR DINING:

Anyone age 60 or older, or their spouse, is eligible. Meal reservations should be made by noon one day in advance. Monetary donations encouraged and eligible persons who qualify will not be denied services if unable to contribute. Located at 220 South 3rd Avenue Suite #1, Wisconsin Rapids. OUR FATHER'S TABLE:

FREE OR REDUCED LUNCH PROGRAMS:

Provides free and reduced price lunches to families that meet income eligibility guidelines. Register through your school district.

SUMMER FOOD SERVICE PROGRAM (USDA):

Provides nutritious meals to children during the summer when free or reduced-price school meals are typically unavailable. Free meals will be made available to ALL children 18 years of age or younger. Various locations available. Call 2-1-1 for details.

OTHER RESOURCES

THE FAMILY CENTER:

Provides emergency food assistance to victims and their families of domestic violence and sexual assault. Located at 500 25th Street N., Wisconsin Rapids. A 24-hour phone line is also available at 715-421-1511.

BACKPACK PROGRAMS

RAPIDS FAMILY BACKPACKS:

Provides nutritious foods needed to make a family meal along with an easy-to-follow recipe. Program is provided to select schools in Wisconsin Rapids for the school year beginning in October. Contact the school's social worker or counselor for more information or to request a backpack.

THE BACKPACK FOR KIDS PROGRAM:
